- (a) The Company supports the implementation of the RSAP for the purposes and objectives articulated therein;
- (b) The Company agrees to be bound by and comply with the RSAP Procedural Rules, as amended from time to time, and;
- (c) The Company agrees Active RSAP Participants shall be exempted from the requirement to submit to a site access test as a pre-requisite to qualifying for site access, and the site access policies of the Company will be amended accordingly.

Where the Company is mentioned in this document or any other RSAP document, the term shall be taken to mean the person or persons designated by the Company in respect to participation in the administration of portions of RSAP, wherever that context is appropriate.

**It is further understood** that this agreement may be withdrawn by the Company, with or without reasons, on 90 days' notice to the RSAP Administrative Committee. Through the course of implementing said notice, RSAP Participants presently on the Company's site shall be grandfathered such that they will continue to qualify for access to the site without the requirement of submitting to a site access test for the duration of their continuous employment on site.
