Reconsideration of Umpire Weir's November 28, 1999 Decision – File #9915 Removal/Replacement of Control Valve Position Transmitters Project Joffre Co-Gen

1. SPANTEC'S ASSIGNMENT

Spantec's November 02, 1999 letter by Ron Galey, Western Regional General Superintendent states:

"The Jurisdictional Disagreement on site with regards to the above mentioned removal and replacement of Fisher Control Valve position Transmitters is hereby assigned to the United Association of Plumbers and Pipe Fitters. This award is based on the January 5, 1984 I.B.E.W. Memorandum of Understanding. The Monitoring Switch (Position Transmitter) is mounted to a tapping on the valve and is activated by a mechanical device. This award is consistent with item b. in the above mentioned Memorandum of Understanding (copy attached). This Award is also consistent with the Transmitter clarifications dated March 26-27, 1973, New York City, New York. The transmitter is part of the valve and is delivered to site as such, - (Page EW-37) – copy attached.

This Award is made with out prejudice and is for this project only. The affected parties are reminded of the process to deal with jurisdictional disputes if they disagree with this award."

2. J.A. PLAN FILE #9915 UMPIRE'S DECISION

The IBEW have requested Reconsideration of Umpire Weir's Decision, which stated;

- Spantec's assignment is upheld.
- The Umpire's costs shall be paid by the IBEW.

3. RECONSIDERATION REQUEST

The request for Reconsideration was brought by the IBEW in their December 06, 1999 Reconsideration Application. An oral hearing was requested.

The basis for Reconsideration was stated as:

"It is the opinion of Local 424 IBEW that the Umpire did not fully appreciate, nor take into consideration when arriving at this decision, what is involved with the installation of the control valve position transmitters."

4. **AUTHORITY**

The authority of the Umpire is based on the Jurisdictional Assignment Plan of the Alberta Construction Industry, the Application submission by IBEW and responses submitted by UA and Spantec by way of oral evidence.

5. ORAL HEARING

An oral hearing was held on Wednesday, April 05, 2000, 1350 to 1520 in the Alberta Arbitration and Mediation Society meeting room, Decore Centre, University of Alberta, Edmonton, AB.

8. J.A. PLAN ARTICLE VI: PROCEDURES TO BE USED BY THE UMPIRE

In making my decision I have followed this procedure.

9. FINDINGS

From the Evidence submitted I find:

- I do not agree with the IBEW's analysis of the integrity issue.
- The February 14, 1972 Alberta Labour Department document has relevance, is fundamental and applies to this matter.

If not what is the significance of decisions recorded in the Green Book going back to 1920 or earlier and referred to as "Agreements of Record" in the J.A. Plan?

• There was not agreement that the instrument in question at Hinton, Alberta was the same to the ones in question.

The commonality is both are electric.

The UA's witness, Mr. Boenig, gave creditable testimony commenting on his thirty
years in the area of instrumentation and indicated in at least 95% of the cases the valves
come complete as ordered and if not the UA installed the switches and the IBEW
always did the wiring.

His evidence was not challenged.

I'm sure in thirty years Mr. Boenig has witnessed many technological changes in instrumentation components.

• I accept the IBEW's comments with respect to the evolution of change to electrical and electronics

These changes in technology will increase at a progressively faster rate resulting in previous decisions not being applicable to the new products.

In the future J.A. Plan Umpires' decisions will reflect this.

I strongly recommend the IBW and the UA revisit and resolve this matter to the betterment of both and the elimination of alleged job site harassment.

As stated in my comments to the fifth bullet on page 8 of 10 of my J.A. Plan File #9915 Decision:

"This may serve as a template between the UA and IBEW for a workable Agreement between them."

• After reviewing all the J.A. Plan File #9915 evidence and #0003 evidence I find no new evidence that would change my Findings (page 10 of 10) in J.A. Plan File #9915.

10. THE RULING

- Spantec's assignment is upheld.
- The Umpire's costs shall be paid by the IBEW.
- This decision is for this project only.
